#### EURO MEDIUM TERM NOTE PROGRAMME

This supplement (the "Supplement") to the base prospectus dated 24 November 2022 (the "Base Prospectus"), constitutes a supplement for the purposes of Article 23.1 of Regulation (EU) 2017/1129 (the "Prospectus Regulation"), and is prepared in connection with the €3,000,000,000 Euro Medium Term Note Programme (the "Programme") of illimity Bank S.p.A. (the "Issuer"). This document is supplemental to, and should be read in conjunction with, the Base Prospectus and, in connection with any issue of securities thereunder, with the relevant Final Terms. Therefore, with respect to issues under the Base Prospectus, references in the Final Terms to the Base Prospectus are to be read as references to the Base Prospectus as amended and supplemented. Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement has been approved by the Commission de Surveillance du Secteur Financier (the "CSSF"), as competent authority under Prospectus Regulation. CSSF has only approved the Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or of the quality of the securities issued under the Programme and investors should make their own assessment as to the suitability of investing in the securities issued under the Programme.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer, the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the importance of such information.

With effect from the date of this Supplement the information appearing in, or incorporated by reference into, the Base Prospectus shall be deemed amended and/or supplemented in the manner described below. References to page numbers are to the pages of the Base Prospectus.
